

ANNOUNCEMENT OF THE IMPORT TENDER P.C 165/NT/2015

The Ministry of Electricity / General Directorate of Electrical Transmission Projects (ETP) would like to invite the manufacture companies exclusively for underground cables to participate in the a/m tender which include ((Supply of (132 kV) (1*800 mm²)Underground Cables & Accessories for Joining Projects (Substations):-

(Al Arbajyia132kv S/S – AL Tahrer S/S)-(AL Touse\2 132kv S/S – Old Touse S/S)-(Al Sader Gas Station (2) 132kv S/S – AL Sader S/S)-(Aadhmiya (2) 132kv S/S – Al Sader Gaz Station (2) 132kv S/S)-

(AL shula 132kv S/S – Baghdad North West 132kv S/S)) , Estimate Cost is (57 145 000) USD fifty seven millions one hundred forty five thousands USD according to below conditions:

- 1- prices to be on CIP delivery to warehouse basis of Incoterms (2010) in USD or EURO.
- 2- payment conditions to be by irrevocable L/C issuing through Trade Bank of Iraq (TBI) according to the availability from the budget in 2015 as follow :-
 - 35% (thirty five percent) of each shipment to be paid upon crossing of goods at Iraqi borders and payable at sight against presentation of the shipping documents:
 - 60 % (sixty percent P) of each shipment to be paid after arrival of goods to warehouse and to be approved when been received .46tyght66665
 - (5 %) (five percent) of total contract price will be paid after execution of all obligations of second party.
- 3- the commercial (1 original and 2 copy) and technical (1 original and 2 copy) offers to be submitted in two separate sealed and stamped envelopes at the below closing date to the ETP seminar (offers opening committee) which will meet in presence of company's authorized person , As well as , submitting the approved legalized certificate of registration and foundation of the company in English and Arabic language, company profile, reference list ,purchase receipt , approved Audits for last three years, your company Capital and financial efficiency to be attached with commercial offer in the name of participant company, (ISO) certificate , a commitment should be submitted from the contractor that it will not employ any staff from MOE in this project under above mentioned tender .
- 4- Operative bid bond amounting (1%) in USD or Euro from the total amount of the offer valid for four (4) months enclosed with the commercial offer from any reliable bank through TBI to be submitted with commercial offer according to conditions of Bank Guarantee which is issued by MOP; otherwise , the offer will be neglected and the contractor should adhere to extend the validity period of bid bond amounting 1% until signing the contract .
- 5- A- operative performance bond amounting to 5% of the total contract price from any reliable bank Through TBI to be submitted after awarding before contract signing and will be released at the End of warranty period and settlement of final audits according to conditions of Bank Guarantee which is issued by MOP.
B- Warranty and maintenance period should be clearly mentioned in the offer to be completely Covered by the performance bond .
- 6- Contract Period (540 days) only from the commencement day (signing the contract) .
- 7- A- The below equation should be applied when calculating this penalty ;
[contract amount (the original contract amount ±any change in amount) / total contract period (original contract period ± any change in period) ×(10)%] penalty for each day. and the instructions of governmental contract's implementation (No. 2 for year 2014) which is applied on this tender .
B-the contract subjected to article N0.9 /4/B from instruction of Governmental Contract execution No. (2) for year 2014 and subject to Iraqi Laws and applied legislations..
- 8- the liquidated damages will be deducted according to contract execution percentages which are specified in contract execution curriculum and that the executed work for the supplied goods or the ordered service should be identical and prepared for use according to contract conditions
- 9- the tender is included in the investment regulation subjected to Iraqi laws and applied legislations .
- 10- Administration charges: contractor shall afford Administration charges not exceed than(20%) from total cost of work execution, when employer execute any of contractor obligations after being delayed in performing what is required according to this tender.
- 11- Inspection to be performed by recognized international inspection company and should be a member in (IFIA) as well as , accepted by ETP the bidders bear all expense , and an inspection certificate to be submitted (SGS COMPANY is not accepted) .
- 12- Employer is not bond to accept lowest offer.

- 13- Offer validity (120) days from the closing date of the tender and contractor committed to extend it until signing the contract.
- 14- Origins of goods is to be clearly indicated .
- 15 - The Iraqi security situation is not to be considered as force majeure
- 16 - The contract to be signed should be written in English and Arabic language.
- 17- Any dispute or difference arising out of the execution of the contract shall be settled amicably in the event of non- agreement, the subject shall be referred to the Iraqi courts and the Iraqi law and regulations shall be applied.
- 18- Any offers differs from the tender conditions or specifications will be neglected even if it's price was the lowest
- 19- The contractor must bear the announcement cost.
- 20- Tender documents price is (2 000 000) ID only TWO Million Iraqi dinars should be paid cash in ETP Directorate and could not be returned .(except in case of tender cancellation) .
- 21- Offers should be submitted before or at 12:00 NOON ON Wednesday 21/10/2015
- 22- The date of opening technical and commercial offers at the same closing date at 12:00 NOON on Wednesday 21/10/2015.
- 23 - In case of that the closing date being a holiday, tender will be closed & opened on the day after the closing date directly at 12:00 noon.
- 24- Companies & representatives` E-mails should be fixed as corrected & clear for correspondences.
- 25- To submit the offers in English or Arabic (if possible).
- 26- Tenders` representatives should attend opening offer (technical & commercial) at ETP office .
